June-July General Assembly voting results

General Assembly votes support all bylaw changes and clarifications.

All six bylaw changes and clarifications that were voted on as part of the June-July General Assembly were supported, attracting between 95% and 100% support from the 37 members who voted, of 429 eligible members. Key changes are that:

- The ITD Alliance can now grant lifetime membership to individuals and institutions that make exceptional contributions.
- The Leadership Board will temporarily have an ex-officio member, who is a representative of the Swiss Academies of Arts and Sciences. This position will be responsible for a range of specific duties and will remain in place until the ITD Alliance is able to be fully self-sufficient. This formalises the current situation.

- Seven of the 15 places on the Leadership Board are reserved for members from the Global South; places are no longer reserved for representatives of institutional members, with representatives of institutional members still strongly encouraged to nominate for the Leadership Board.
- The voting rights of institutional members are now clearly defined, with each person "nominated to receive benefits" by an institutional member entitled to vote.

Grappling with Transdisciplinarity: Tips and Challenges, Webinar, ITD Alliance Oceania Regional Network, 31 July 2025

The ITD Alliance Oceania Regional Network invites you to a webinar on 31 July 2025:

Grappling with Transdisciplinarity: Tips and Challenges. A dialogue between Allan O'Connor (Adelaide University, Australia) and Allanah Ryan (Te Kunenga ki Pūrehuroa Massey University of New Zealand).

As the leadership of universities and related organisations increasingly embraces transdisciplinarity in research and teaching as a way of tackling complex societal and environmental problems, what does it mean for those on the ground who are tasked with introducing transdisciplinary approaches? Adelaide University in Australia (which is newly established from an amalgamation of the University of South Australia and the University of Adelaide) and Te Kunenga ki Pūrehuroa Massey University of New Zealand are leading institutions addressing these challenges. Allan O'Connor and Allanah Ryan are heading up the change processes and have rich experience to share. They will make brief scenesetting presentations about their university's context and approach to transdisciplinarity, what their institutions "have going for them," and the main challenges, along with how they are addressing them.






